Burnett has served as head of Gator for over 10 years and will bring his industry knowledge and relationships to the Quala platform. "The Gator team is excited to join Quala and believes Quala's facilities and broad capabilities provide opportunities to expand customer relationships and attract new customers in our current markets as well as new geographies," said Burnett.
